Master of Stables – HE Steinn

- Armoured: HE Steinn
 - Weekly armoured practice on the stage. Four to ten participants per week. The stage works well for combat.
 - Authorized a number of new fighters, as well as promoted two fighters to become Junior marshals. Glad to see the growth of the shire's fighting community.
- Archery Teitr
 - There was one indoor archery practice hosted by the Penticton Archery Club on Nov. 22nd. We had 10 attendees at the practice.
 - Due to an early Black Friday sale on bulldog archery targets, I have purchased 4 targets using the shire's pre approved archery supplies funds. 548.90\$ The targets arrived on Monday, Dec. 2nd.
- Thrown Weapons HE Olen
 - No report at time of posting.
- Rapier Gawain
 - This month was a busy one for rapier practice. For clarity, I've organized this report into the following sections: Super Practice, Regular Practice, and Baroness' Inspiration and I have tried to be concise.
 - o Super Practice
 - We hosted a highly successful Practice Rapier Tournament during the November 9th Super Practice, with over 20 participants.
 - As it was a practice setting, we allowed non-authorized fighters to participate under the supervision of a Senior Fighter to assess safety. Despite these precautions, two injuries were reported, caused by the

- same fighter. This issue was escalated to the Principality Marshal, who addressed it appropriately.
- Moving forward, we will implement stricter guidelines for non-authorized participants and reinforce safety protocols, including proper sword use and procedural discussions before events.

o Baroness' Inspiration

- Danescombe was well-represented both on and off the field. Highlights include Don Enoch being placed on vigil (huzzah!) and exceptional performances from our fighters. For the fourth (or fifth?) year running, Gerhard's Riposte was awarded to a Danescombe fighter—this year, Micholaj (sp?).
- Concerns were raised regarding some newer fighters not meeting expectations for fair play and safety during bouts. These issues have been addressed by senior leadership in the rapier community and will remain an ongoing point of focus.

Regular Practice

- Practices have been well-attended throughout the month.
- Mateo has been instrumental in sharing practice duties and contributing to discussions about potential improvements.
- Kristophe has resumed teaching his Rapier Fundamentals class, which we hope will help address some of the challenges with newer students.
- Tobias, Murdoch, Enoch, Mateo, and I met to discuss the practice's future, including space utilization, the needs of both rapier and C&T fighters, and current challenges. Together, we developed a plan to address these concerns.
- We've restructured the practice space to better accommodate our growing numbers, designating areas for C&T, open practice, and classes.

Addressing Challenges

- Some specific issues with newer students include:
- Fair and decisive blow calling
- Reporting promptly to lists after bouts
- Minimizing post-bout discussions
- Delivering safe strikes (stiff shots have been a concern) These matters will be tackled through direct communication and focused training. Thank you for your attention and support.

• Cut & Thrust - Lord Tobias

- Cut and Thrust has been given more dedicated time and space. This has allowed for much more participation, and looks like it will result in increased growth of the the C&T community within the shire.
- We had 3 C&T practices with 8 participants across the month.

Arts and Sciences - Archibald Archer

Chatelaine – Reagan

- I received a request to get a hold of a couple. They wanted to know if there were any recent activities that they could attend. I explained to them that there was a super practice, and they informed me that they will be attending.
- I was told by gate that a couple had asked for the chatelaine, but the gate forgot who chatelaine was, so they directed them to Murdock.
- I did approach the one couple, that I did not recognize, and I chatted with them while I was waiting to partake in the rapier tournament. They had left by the time it was all over. This couple did ask if there was going to be a yule feast, I did inform them that there would not be one.
- There were no other interactions with anyone else for November.

Scribe - HE Taliesin

- Scribal evenings at Fighter Practice and at HACC are proceeding as normal. We were
 able to send off a number of painted charters to Baroness' Inspiration for the Principality
 of Tir Righ. As a result they sent back additional charters for painting. We are waiting
 for charters for the new reign but don't anticipate receiving until the new year.
- I am also working with the Governor of TUTR to set up Novice Classes for our event in February.
